8. If you are a naturalized citizen, provide the date and place of naturalization.
9. With respect to your career, how many years of law enforcement experience do you have?
10. Summarize your experience in law enforcement prior to the last five years.
11. If you are currently serving as a law enforcement officer, briefly describe your duties.
12. Have you ever taught law enforcement at a school? If so, which school(s)? When? What was the nature of your appointment? If so, provide details, including dates.
13. If you are now an officer, director or otherwise engaged in the management of any business enterprise (whether for-profit or non-profit), identify the name of such enterprise, the nature of the business, the title of your position, the nature of your duties, the term of your service and whether you would resign such position immediately upon appointment as U.S. Marshal. If you would not intend to resign, please provide the reasons why.

14. During the past five years, have you received any fees or compensation of any kind from any business enterprise, institution, organization or association of any kind? If so, identify the source of such compensation, the nature of the business enterprise, institution, organization or association involved, the dates of such compensation was paid, and the nature of any services rendered by you.
15. Please list all law enforcement positions you have held or have been a candidate for. Identify the position involved, whether elected or appointed, and the dates of the service and dates of candidacy.
16. If you have had prior quasi-law enforcement service, provide the name of the agency, the position held, type of matters handled, the number of matters handled, and the dates of service.
17. If you lack significant law enforcement experience, describe the experiences or special skills you possess which you believe qualify you for the position of U.S. Marshal.
18. Have you ever held public office other than law enforcement, or have you ever been a candidate for such an office? If so, provide details, including office(s), whether elected or appointed, and the dates of your service.

Have you ever been arrested or charged by federal, state, or other law enforcement authorities for a violation of any federal law or regulation, state law or regulation, county or municipal law, regulation or ordinance (do not include moving traffic or parking violations)? If so, state the following for each: the date and location of the arrest and/or charge; the charged violation or reason for arrest; the arresting or charging authority; and the final disposition of the arrest or charge.
20. Has a tax or court-ordered lien ever been filed against you or your spouse on jointly owned property (or a company in which you or your spouse have been a principal), or have you or your spouse, while married, filed for bankruptcy? If so, state the following: the date and location of the lien or bankruptcy filing; the reasons for the lien being filed against you; the bankruptcy court where filed and the case name and number of the petition; and the final disposition of the lien or bankruptcy petition.

Are you, or have you ever been, delinquent for any Federal or State taxes or debts, including debts arising from defaults on Federally- or State-guaranteed or insured loans such as student and home mortgage loans? If so, state the following for each: the position you held at the time and the office address of the position; the legal citation of the legislation, *etc.*, involved; a summary of the legislation and the reasons why it might be construed as discriminatory; and the date(s) of the vote or formation of the legislation.

Have you ever been a member of any organization (e.g., country club, service organization, fraternity, etc.) whose by-laws, policies, or activities could be construed as implicitly or explicitly discriminatory in any way? - e) Is there any other aspect of your health history, which if brought to light during the nomination process, may raise questions about your nomination?

29. Are you able, with or without reasonable accommodation, to perform the requirements of a U.S. Marshal?

30. Have you ever used illegal drugs at any time? If so, give details.
